Membership Rights and Responsibilities

As a valued Member, here's a quick summary of your rights and responsibilities:

Your Rights:

- Stay informed and engaged: Receive notices, attend, speak, and vote at general meetings—this includes voting for Elected Directors. (Note: rights are on hold if fees are unpaid.)
- Influence leadership: Nominate one individual for consideration as an Elected Director (as long as they meet ASIC and ACNC requirements and are not your nominated Representative).

Your Responsibilities:

- To appoint a Nominated Representative (an officer or senior executive) to exercise your rights on your behalf at our AGM or General Meetings.
- If InGeNA were to wind up, your contribution to any outstanding liabilities would be limited to just \$1.

Membership Fees

Company size	Australian revenue	Annual membership fee	Additional recognition of Australian owned companies
Start-Up	\$0-5M	1st year of membership \$500; 2nd year of membership \$750; 3rd year of membership \$1000, then moves to Band 1.	
Small business	<\$10m	\$1500	
Band 1	>\$10m-\$75m	\$5k	10% discount
Band 2	>\$75m - <150m	\$10k	10% discount
Band 3	>\$150m - <250m	\$15k	10% discount
Band 4	>\$250m - <500m	\$20k	10% discount
Band 5	>\$500m	\$25k	10% discount

A discount of 10% if there is an upfront three-year commitment of Membership (invoiced annually) is available for Band 1-5 based on application.
